

Highlights of the year included EHS Spirit Fridays, PASS party, and numerous field trips. The Mission of East End Elementary is "Excelling in Academics, Encouraging Character, Embracing the Community, and Seeking Success for All Students." Our PTO and SIC are two strong and very vital forces in making this happen. East End's SIC and PTO are the greatest and strive to do the very best for the well-being of our students. This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target.
