Percent of Student PASS Records Matched for Purpose of Computing Growth Rating



Report of Principal and School Improvement Council

Mary Bramlett has focused on a school-wide theme, "Learning for the 21st Century," and we are presently restructuring our curriculum. We have adopted new ELA books, and we are working closely with our school-district on implementing the Common Core State Standards.

We believe the Common Core State Standards will challenge our students to be prepared for college and the work place.

100% of our teachers are on board and looking forward to learning more about Common Core Standards. Technology is essential for getting ready for the 21st Century. We have purchased iPads and iPods as a way to differentiated instruction for students with different learning styles, and we have focused on providing all students with innovative strategies that are research-based.

Mary Bramlett continues to provide students a pleasant and conducive school atmosphere for learning and growing intellectually and physically. We dedicate our efforts to implement the best research-based strategies and practices available, and we preface these implementations with high expectations. Our school is a PBIS school and students enjoy getting their incentives for great behavior, and we appreciate our community members who have donated funds and materials for this purpose.

We have extended the instructional time to increase the rigor, allowing teachers to teach in-depth reading and math skills. Research shows that children who are engaged in intense and effective instruction from age 0 to 6 have the best chance of retaining new information. Therefore, we have a probably chance of closing the achievement gap for grades k through 5 before reaching middle school.

Even though we are a (Priority School) we will continue to provide small group, differentiate instruction, Response to Intervention, Math Exploration, Study Island, MAP, science lab, mentoring, smart boards, instructional facilitators, Mobile Library, Supplemental Education Services, World of Readers, reading and math interventionist, field trips, and parent and community involvement as a means of reaching all of our children.

ESEA/Federal Accountability Rating System

In July 2012, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years.
