

**Report of Principal and School Improvement Council**

Johnston Edgefield Trenton Middle School is located in the historic county of Edgefield. The school was founded in 1993 to service the towns of Johnston, Edgefield and Trenton. Since its inception J-E-T Middle School has been focused on providing the best education possible for students in Edgefield County. While striving to provide this quality education, the school has been honored with many awards. This school year J-E-T Middle School was awarded the Palmetto Silver Award for academic achievement. As a T.A.P. School J-E-T earned a valued added 5 rating. This is the highest rating attainable for a school in the T.A.P. Program. J-E-T earned a "B" rating this year based upon student's PASS performance. J-E-T Middle School was honored with the Exemplary Writing Program Award on several occasions, with the latest awarded for the 2002-2005 school years. J-E-T Middle school was a Palmetto's Finest Award Finalist for the 1999-2000 school years. The Palmetto's Finest Award was awarded to J-E-T the next year in 2001.

The Johnston Edgefield Trenton school community takes pride in its accomplishments but is not willing to rest on them. The administration and faculty is currently taking steps to increase the school's competitiveness in the 21st century. New Initiatives such as The Eagle Leadership and Achievement Academy are designed to foster a stimulating academic environment for students. Students are required to perform at a high level academically and display a high level of character in order to be admitted to the academy. Students are active in various service learning projects including peer tutoring and community service. The PBIS model is also being implemented in order to maintain a positive environment where good character is promoted and valued.

Partnerships with higher education institutions such as Clemson University's dropout prevention program and U.S.C. Aiken's Ruth Patrick Science Center were developed by the leadership of J-E-T in order to assist in the school's academic progress. Students are able to take several field trips throughout the course of the year to the Ruth Patrick Science Center and to the Audubon Center. These trips are designed to fit seamlessly into science standards for all three grade levels.

Administrators, faculty and parents understand the challenges that lie ahead for Johnston Edgefield Trenton Middle School. We are optimistic that we will continue to make strides in the right direction as we increase students achievement and increase opportunities for students to value themselves and others. All of our stakeholders are committed to continuing the effort to help J-E-T Middle School soar and provide Edgefield County with one of the finest middle schools in the state of South Carolina.

In July 2012, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target.
