

## Report of Principal and School Improvement Council

Carver Middle School represents excellence in education. Our students have the opportunity to excel in academics, the arts, and extra-curricular activities. We utilize data to focus on the needs of every student in order to maximize their academic and social development. Carver has partnered with the Boys and Girls Club and the Urban League of the Upstate to offer character education and leadership development in collaborative school programs. Carver has also partnered with West Point, Clemson, and NASA for professional development in Science, Technology, Engineering, and Mathematics (STEM) education. During the 2011-2012 school year, we successfully implemented a school-wide STEM initiative that will provide all students with opportunities to be successful in a rigorous academic environment while developing 21st century learning skills. We exposed our students to rigorous STEM-related experiences outside of the classroom. Carver students participated in the West Point STEM Summer Institute and the Middle School to College Program at the Governor's School for Math and Science. Carver has built relationships with local business and community organizations to provide opportunities for all students. Carver received the Minority Advocate Award from the Spartanburg Area Chamber of Commerce because of our commitment our students and the community. We have developed a student-centered academic focus that will allow all students the opportunity to be successful while receiving a high quality education.

Carver embraces the concept of building a community of learners. During the 2011-2012 school year, we became a middle school. We utilized middle level best practices to create a collegial atmosphere in which team planning and instruction focuses on the academic and social needs of all students. Our schedule ensures that teachers have individual planning, collaborative planning, and professional development periods each day. Through our collaborative efforts, students are receiving quality instruction and excellent educational opportunities. We infused the Advancement Via Individual Determination (AVID) program throughout the school to create a college going culture which encourages all students to seek post secondary educational opportunities. Students are recognized for their achievement at Carver. Students are recognized weekly for "Promoting PRIDE" (Personal Responsibility In Daily Excellence). We also honored and recognized more than 400 students at our fourth annual Academic Pep Rally.

At Carver Middle School, administrators, teachers, students, parents, and the community share the responsibility to create an environment that represents excellence in education. We are confident that our efforts will continue to provide an opportunity for all students to be successful.

In July 2012, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years.
