

# **South Carolina Educator Certification Assessment Program**

## **Required Assessments for the 2019-20 Academic Year**

### ***Effective May 28, 2020***

S.C. Code Ann. Section 59-26-30 authorizes the South Carolina State Board of Education (SBE) to adopt nationally recognized educator assessments for certification purposes and to establish qualifying scores on each assessment. The SBE has adopted the Praxis series of program admission, content area, and pedagogy assessments, developed and administered by Educational Testing Service (ETS), for use in South Carolina. Assessments administered by other testing companies have been approved on a limited basis as noted.

### **Testing and Accommodations**

Praxis assessments are computer-based and are offered at testing centers in a variety of locations in South Carolina, across the United States, and in other countries. With acceptable documentation, ETS offers paper-based testing and other appropriate accommodations for test-takers with disabilities and medical-related needs. ### **Registering for a Praxis Assessment**

When registering for Praxis tests through ETS, each test-taker seeking certification in South Carolina must provide his or her **complete nine-digit Social Security number** in order for test scores to be reported to the South Carolina Department of Education (SCDE). Scores are reported electronically and matched to individual records in South Carolina's electronic certification system based on a complete, accurate Social Security number. If a Social Security number is not listed on a test-taker's score report—or is listed incorrectly, processing of that individual's certification will be delayed and may require the test-taker to request an official score report from ETS at additional cost. Test-takers may access their testing information through their ETS user accounts for a period of ten years.

### **Certification Assessments for World Languages**

South Carolina has approved and will accept qualifying scores on assessments developed by the American Council on the Teaching of Foreign Language (ACTFL). Candidates seeking certification in a world language using ACTFL assessments must take both the Oral Proficiency Interview (OPI) and the Writing Proficiency Test (WPT). ### Required Certification Assessments

Candidates seeking an Initial certificate in a classroom teaching field in South Carolina must submit qualifying scores on both the subject area and pedagogy assessments approved by the SBE in order to be eligible for and issued a teaching certificate. Educators seeking to add a classroom teaching, service, or leadership field to an existing, valid South Carolina certificate must earn a qualifying score on the subject area assessment approved by the SBE for certification in the area. Out-of-state applicants who hold a current, standard credential in another state and are issued an Initial South Carolina certificate must present a passing score on a required pedagogy assessment during the three-year validity of the Initial certificate in order to advance to a Professional certificate.

Candidates seeking eligibility for an approved alternative route program must earn a qualifying score on the required subject area assessment in the certification area prior to program admission. They must subsequently submit a qualifying score on the required pedagogy assessment during the three years of program participation in order to advance to a standard Professional certificate.

### Required Pedagogy Assessments

The following pedagogy assessments are approved for certification in classroom teaching fields in the state of South Carolina. Candidates seeking certification in service fields (i.e., School Guidance Counselor, School Psychologist, Library Media Specialist, and Speech-Language Therapist) as well as leadership fields are not required to take a pedagogy assessment.

### Optional Pedagogy Assessments: edTPA and PPAT

Effective January 1, 2018, the SBE adopted the teaching performance assessments, edTPA and PPAT, as options for South Carolina's educator preparation providers to implement within approved teacher preparation programs. These assessments are comprised of a series of performance tasks that candidates must complete as part of a portfolio that is submitted to the respective testing company for scoring. Candidates who are required to complete one of these performance assessments during student teaching to fulfill requirements of the preparation program in which they are enrolled may use a qualifying score on edTPA or PPAT in lieu of the PLT. Out-of-state applicants who completed edTPA or PPAT during student teaching may use a qualifying score on one of these assessments in lieu of the PLT so long as the assessment was

completed after January 1, 2018.

***edTPA (Administered by Pearson Evaluation Systems)***

Candidates enrolled in teacher preparation programs requiring edTPA will receive comprehensive support and assistance from program faculty regarding the portfolio assessment—or handbook—required for their specific certification area (e.g. Early Childhood Education, Mathematics, Middle Level Social Studies, etc.). Qualifying scores are based on the number of performance tasks or rubrics within the specific handbook.
