RE: PowerSchool Upgrade for Uniform Grading Scale

This summer, the South Carolina Department of Education (SCDE) has been working with PowerSchool, to develop a tool to automate the process of changing from the 7 point scale to the 10 point scale. Our goal is to make it easy for our schools to automatically apply the following:

1. 7 point scale to all courses a student has taken for high school credit, prior to the first day of school in 2016–17, and
2. 10 point scale to all courses a student takes for high school credit from this year forward.

In August 2016, PowerSchool provided the SCDE with a “Plug-in”, which is a programming code. All districts will need to install this “Plug-in” in each school where the 10 point scale will be applied, in order to make these changes happen automatically. Over the last few weeks, the SCDE has worked with twelve districts to pilot the “Plug-In” on test servers. We have been able to resolve several unique situations related to individual district PowerSchool databases with the developers. The “Plug In” is now ready to implement across the state.

Beginning Wednesday, August 24, 2016, we will provide the “Plug-in” programming code to twenty-three districts for installation. The PowerSchool support team has assured us they will be ready to provide immediate help to districts as they implement the “Plug-in.” After these districts have successfully implemented this upgrade, we will move in a systematic fashion across the state to implement the upgrade in each district (*see attached list*). The reason for the phase in model is to ensure that PowerSchool has the appropriate support staff on standby to answer district questions.
