Asset Transfer of Ownership from \_\_\_\_\_ (Private School) to the South Carolina Department of Education (SCDE) pursuant to the Emergency Assistance to Non-Public Schools (EANS) program as authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA Act).

The SCDE has been tasked with the provision of services, including reimbursement for allowable expenditures, from EANS funds to eligible, participating, nonprofit private schools, with an approved application. One acceptable use of funds is for the reimbursement of assets purchased by private schools after March 13, 2020, provided that the Private School provides supporting documentation of reasonable costs, and contingent upon the approval of the application by the SCDE and availability of funds.

Both parties to this Transfer of Ownership recognize the importance of adhering to all legal requirements regarding the transfer of assets, to include educational technology, such as computers, laptops, tablets, from a private school to the SCDE.

The Private School, in consideration of the reimbursement, understands and agrees that all responsibility, liability, maintenance, warranty, and concomitant expense regarding this asset and its use remains with the Private School and is not assumed by the SCDE. The SCDE may not transfer ownership of the asset without first informing the Private School. Possession of the asset will remain with the Private School through the grant period ending September 30, 2023, upon which the SCDE will follow disposition of the asset detailed herein pursuant to state agency disposition policies, procedures, and processes.
