**Percent of Student PASS Records Matched for Purpose of Computing Growth Rating**

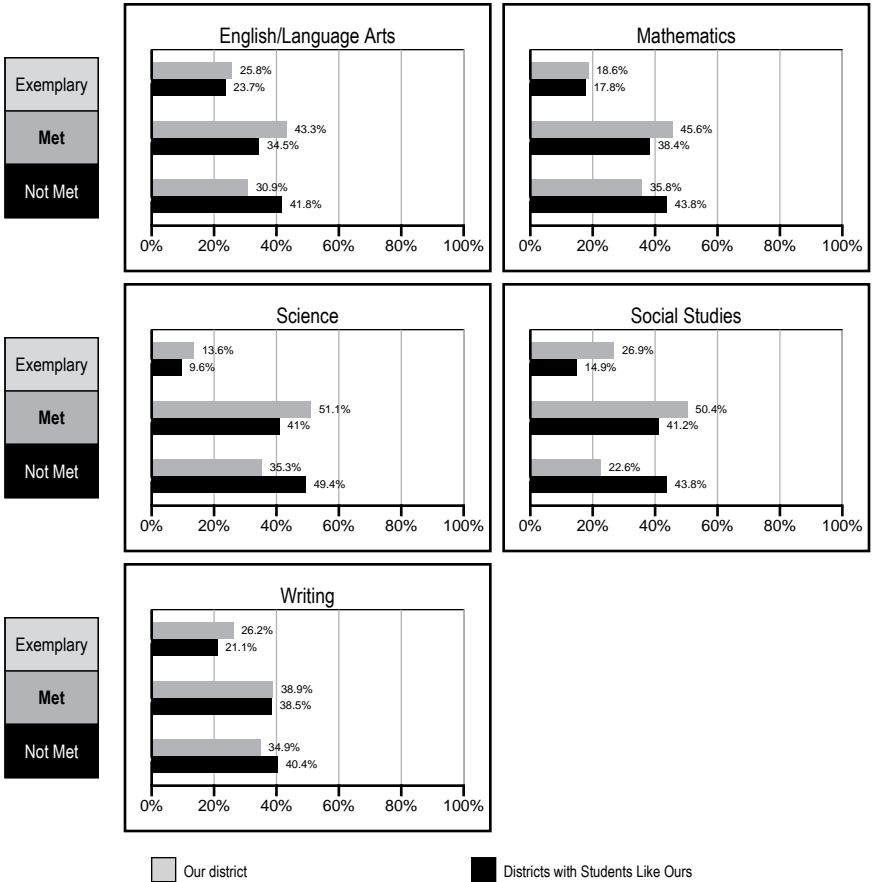

Clarendon School District One is embracing the Common Core Standards. All core teachers are participating in professional development for Common Core Standards. All teachers and administrators are actively engaged in proven research based professional development to enhance learning for students and teachers.

Our high school will soon be designated as a New Tech High. Our middle school met AYP for the third consecutive year. The Early Childhood Center is nationally accredited and St. Paul Elementary serves as a demonstration site for Reading Intervention. The School Improvement Grant is helping to transform the culture of our high school into a student centered school of academic excellence.

We continue our efforts to recognize students for citizenship and academic achievement. Additionally, some of our students continue to win various contests at the local, regional and national level. Specifically, the art work of one of our students was recently selected to be on display in the Cannon Building in Washington, DC for a year.
