Percent of Student PASS Records Matched for Purpose of Computing Growth Rating

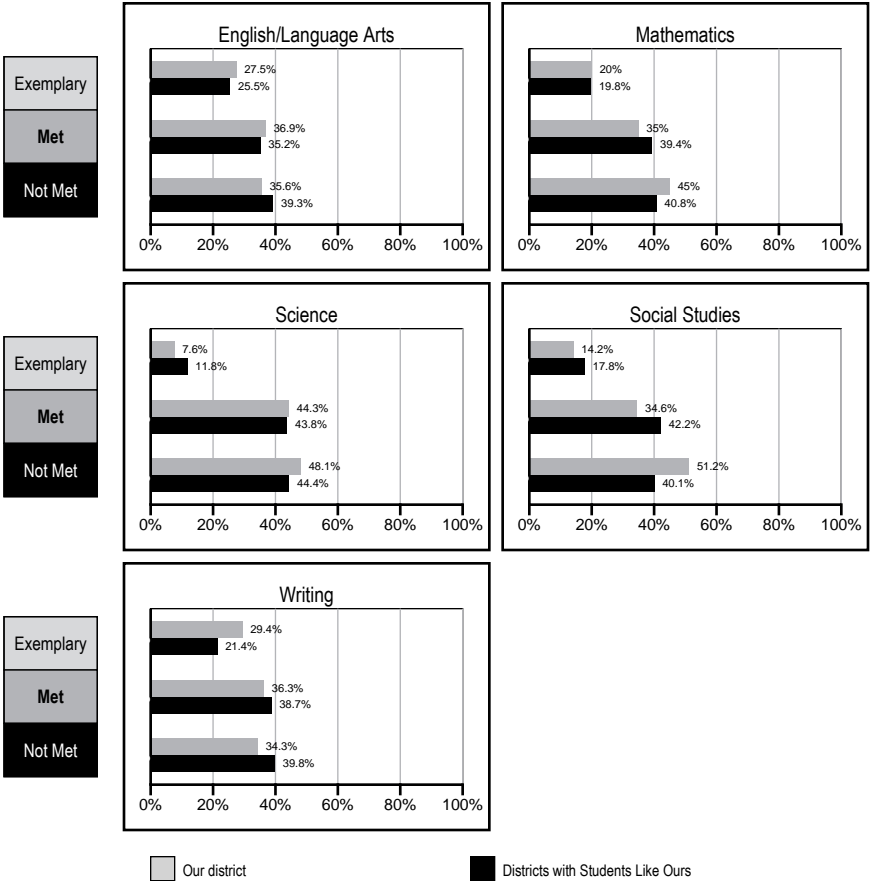

This has been a year of growth for the McCormick County School District. We implemented a new style of administration at the Pk-12 Complex which included a PK-12 principal, three instructional leaders and three behavior modification specialists. Board members are very supportive of the changes implemented by Dr. Smiley, Superintendent of Schools, to improve teaching and learning.

Staff had the opportunity for training this past school year in the areas of Spring Board, Advanced Placement, Positive Behavioral Interventions and Support, PowerTeacher, classroom management, data analysis and other professional development.
