Percent of Student PASS Records Matched for Purpose of Computing Growth Rating

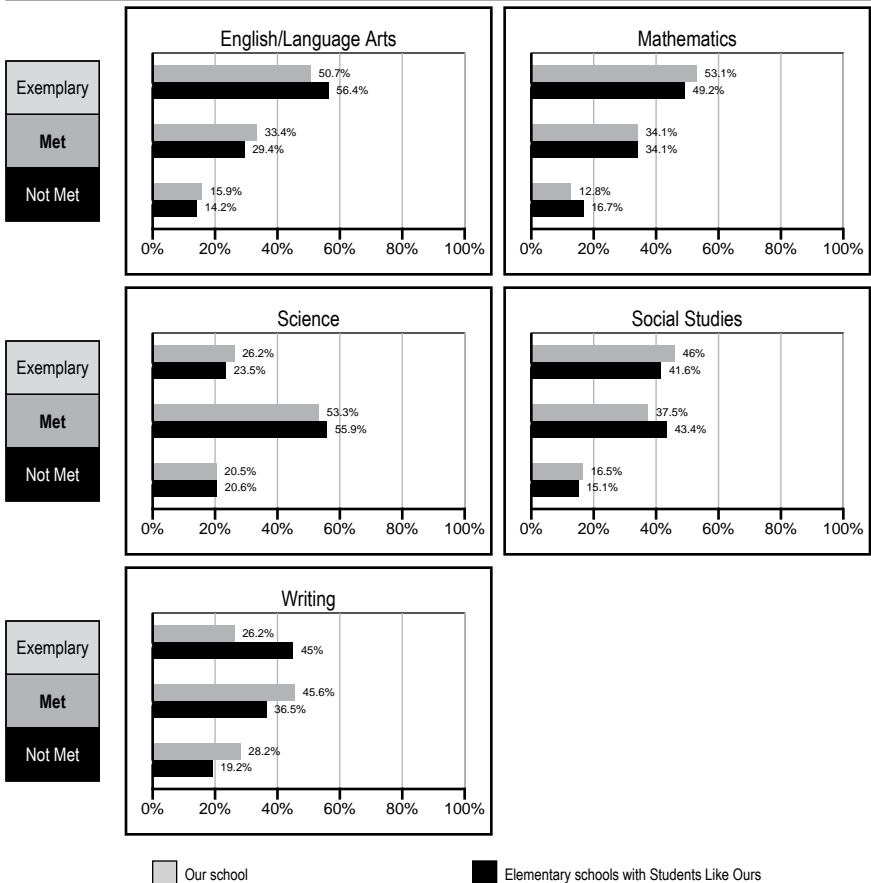

Report of Principal and School Improvement Council

At Anderson Mill Elementary School our mission is to develop competent and confident learners by creating a safe, positive, innovative environment where the staff, parents, and community work together to provide a curriculum that recognizes individual differences. It is the intent of the faculty and staff to lead students toward being disciplined, productive, informed, and fulfilled individuals. To achieve these ideals, we have implemented a school-wide character development program that fosters mutual respect and understanding between the faculty and staff, students, families and the community. The program is taught during classroom guidance and integrated throughout the curriculum. Children who exhibit good character are publicly recognized routinely through programs such as our monthly Kiwanis Terrific Kid breakfasts and weekly Good School Citizen awards.

During the 2011-2012 school year, our faculty focused on research based, reading strategies designed to improve fluency, and phonemic awareness to instill in children a desire and love for reading. Kindergarten and first grade teachers utilized DIBELS (Dynamic Indicators of Basic Early Literacy Skills) to guide their instructional practices and identify children who would be served by the My Sidewalks curriculum, led by our RTI (Response to Intervention) teacher. Second through fifth grade teachers differentiated instruction in the classroom, using explicit direct instruction with developing readers. This year we implemented a math RTI program using the SRA Number Worlds Curriculum for kindergarten through second grade students. A CBM (curriculum based measurement) benchmark was administered to all first grade students. The selected group scored an average of 56% on the benchmark pretest, compared to their peers' 77% average. After intervention, the students served in RTI scored 96% on the benchmark posttest, compared to their peers' 99%. The implementation of these programs, in conjunction with a rigorous curriculum and an individualized approach to instruction, helped our students see tremendous gains in MAP (Measures of Academic Progress) scores, PASS (Palmetto Assessment of State Standards) scores and overall academic performance in the classroom. Because of these accomplishments, we received the SC Department of Education Palmetto Gold & Silver awards for academic performance in math and language arts.

In addition to our academic success, our children had the opportunity to experience personal gratification as we embraced several community outreach projects. Our school collected over \$1400 for Mobile Meals, ranking us first place in our district! Our students, faculty and staff also collected over \$13,000 for Relay for Life, ranking us one of the top elementary schools in our area. What an accomplishment!

We appreciate the support of our families, business partners, PTO, and School Improvement Council as we continue our tradition of excellence at Anderson Mill Elementary. We look forward to the opportunity to maintain our partnership as we strive toward continuous improvement in our service to children.

In July 2012, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years.
