

Charleston School of the Arts takes great pleasure in announcing that we have been recognized as one of the top tier schools in our state. We most recently were recognized with a National Gold Medal by US News & World Report as well as placement in the Nation's Top 1000 Schools from Newsweek Magazine. These recognitions are based on several high performance factors and ratings. Ninety-four percent of our senior student class will be pursuing post-secondary opportunities. We continue to take great pride in our academic rankings and performance-based recognitions. Moreover, we continue to be very proud of being viewed as one of the top-performing schools in the nation.

The fine arts programs in our school have received national acclaim. Creative writing and visual arts students have again been recognized in New York with top national awards from the Scholastic Company. Ratings of "Superior" have been bestowed upon our students at nationally adjudicated band, orchestra, and vocal music competitions. Additionally, our student theatrical productions, dance performances, and piano recitals are magnificently presented and continue to endow our school with honors and awards.

Performance scores from College Board in our nine Advanced Placement courses rank us among the highest in the district and extremely competitive statewide. ESEA/Federal Accountability Rating System

In July 2012, the South Carolina Department of Education was granted a waiver from several accountability requirements of the federal Elementary and Secondary Education Act (ESEA). This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years.
