Chairman Dr. Mathis,

As you may be aware, GREEN Charter School of Greenville's middle school campus has been hit this winter by a series of unfortunate events. First, the school endured vandalism the weekend of December 13th which resulted in a flooded school in need of water damage restoration. Then, the school endured multiple winter weather events, resulting in the need to pivot student learning. GREEN Charter School of Greenville's middle school campus (School) is a public charter school authorized by the SC Public Charter School District (District). The School serves grades 6-8 on Century Drive in Greenville, SC. The School is a state-approved eLearning site.

On March 12, 2026, the School's Board of Directors approved an updated school calendar, adding May 28 as the fourth make-up day. The Board also approved a Local Board Waiver for closure days 5 - 7 and authorized the District to submit a request to the State Board of Education for a waiver of closure days 8 and 9 on the School's behalf.

On March 19, 2026, the District Board voted to approve the School's waiver request at its regularly scheduled board meeting. Therefore, on behalf of the District Board of Trustees, Superintendent Neeley, and GREEN Charter School of Greenville's middle school campus, please allow this to serve as a formal request for the State Board of Education approval to waive closure day 8 (February 2) and day 9 (February 3), for GREEN Charter School of Greenville's middle school campus.
