Additionally, a summary of questions and answers shared in the chat is provided below. Q: Will DRC's site only allow the no calculator section first, followed by calculator? A: At this time, there's been no update to the testing engine for DRC. Districts are responsible for ensuring that the math test is administered in the correct order. Q: Is the universal test security affidavit only for SC Ready, or are we moving in that direction for all assessments? A: The universal affidavit only applies to SC READY and EOCEP. Q: Who did the information for the SC Alt Technology Webinar get sent to? A: The email should have been send to your district technology coordinator. Q: Will test security agreements be added back into the TAMs? A: SCDE removed all appendices from the TAM and the necessary information was either moved elsewhere in the TAM or, if they were reproducible materials, they've been placed on the Portal. Q: Regarding training students - we have integrated many procedures and targeted training slides. You mentioned other districts had some great things going. Does anyone have a video? A: As a team, SCDE will reach out to districts who may be willing to share examples of videos they have created.
